- Proposal to add debit card usage rules and spending limits to the Bylaws (on agenda for June)
- DM will obtain mailbox key from GM to be another person to check mail.

## **Recruitment/Fund Raising**

- BP reported that memberships for 2008 were 19, so far this year we only have 3. LY had sent out renewal letters but 14 returned with wrong address. LY will note these for her records.
- DF emphasized that memberships are really key to maintaining DogPAC as a viable organization. All agreed and membership will be a primary focus this Spring and Summer,
- DM noted the Fetch mailing list might be a good source of new memberships, perhaps devoting an issue just to that.
- Since Tour de Dog received no support from SLN, decision to postpone event until fall, though start planning in July and shorten route. Dog washes for July and August, no dates set.

#### **Data Base**

After discussion of longstanding complications of having 2 databases, DF recommended consolidating the
databases into one MySQL database that all board member would have access to. DF and BS will explore this
and how it could be implemented.

- BP received latches for lockbox at GBP. Gave to DF who will install one and LY will store the extra 4.

  will explore installing a low mesh fence along park fence to minimize trash blowing into the park and to help keep
  it clean and block less desirable view. SD and DF to make up tentative wish list for Coliseum improvements to
  submit to board for review.
